POSITION PURPOSE

Under general supervision, is responsible for performing law enforcement and security duties within the Columbus Regional Airport Authority (CRAA) community. Understands and demonstrates a commitment to the Columbus Regional Airport Authority's Mission Statement, Business Plan, and Core Principles in addition to all other Authority sponsored initiatives.

ESSENTIAL FUNCTIONS AND BASIC DUTIES

Assumes responsibility for the effective performance of assigned law enforcement and security functions and activities.

- Responds to overt and covert alarms at the airport security checkpoints and throughout the terminal.
 - Investigates improper or unlawful acts, i.e. public disturbance, security breaches, assault, etc.
 - Completes and maintains federal, state, local offense and informational reports, files and records.
 - Conducts fact-finding and/or informational interviews.
 - Exercises officer's power/authority to arrest in accordance with TSR: 49 CFR Part 1542 and the laws of the State of Ohio and City of Columbus.
 - Assists in search for suspicious items/bombs in the event of threat.
 - Takes vehicle accident reports on the Airport Authority property.
 - Provides special security for VIP's.
 - Patrols terminal and the Airport Authority property, recognizing/responding to potential security breaches.
 - Escorts emergency vehicles on the airfield when necessary.
 - Performs traffic control responsibilities.
 - Processes lost and found property, and evidence, and records all transactions according to established procedures.
 - Investigates and documents activities of questionable behavior observed on Authority premises.
 - Responds to activated fire, burglary or other alarms as needed.
 - Provides Community Policing and Crime Prevention services.
 - Performs law enforcement duties as specified by the Airport Security Program and Airport Emergency Plan.
 - While performing drug interdiction, works closely with any task force and/or mutual aid agencies responsible for enforcing illegal substance statutes.
 - Responsible for asset seizures involving possession of illegal drugs.
 - Available to respond at any time to assess possible possession of illegal drugs activity.
- Fosters employee relations as established by the Authority.
- Adheres to and upholds all Authority Work Rules, policies, and procedures adopted by the Authority (e.g. - harassment, discrimination, hostile work environment, etc.).
 - Represents and conducts self in a professional manner.
 - Expected to exhibit appropriate and professional clothing and personal grooming habits as outlined by the Authority.

Miscellaneous

- Maintains and supports a high level of customer service to peers, partners, and passengers.
- Adheres to safe operating procedures set forth by the Columbus Regional Airport Authority
