Subject: Executive Institute Committee 2018 Annual Report

During the past year, the Executive Institute Committee (EIC) provided guidance and support for the continued success of the Police Executive Leadership College (PELC). Under the committee's leadership, PELC continued to provide law enforcement executives with both, unique and innovative training. The program which focuses on providing executive leadership educational programming is geared towards today's demands and tomorrow's needs. Graduates continue to evaluate the program as most important and productive, and report a high level of satisfaction with the overall quality of the program. The EIC continues to evaluate and make changes to ensure that PELC training is relevant and effective.

The EIC met on a regular basis this past year to assist the current Program Director Bruce Adams and Monica Miller, Program Coordinator in presenting two sessions of PELC. The committee assisted in the review of PELC applicants, review of potential new instructors, curriculum review and instructor evaluations.

The following are some of the important highlights of the committee's year:

- There were a total of 71 graduates from the PELC 73 and 74 classes in 2018.
- Through the graduations of PELC 73 and 74, a total of 2,204 executives have graduated from PELC since its inception in 1996.
- Student enrollment continues to be strong, with both classes in 2020 fully registered. We are currently scheduling into Fall, 2021 for upper command and into 2022 for all ranks.
- The committee also assisted in reviewing potential instructors for instructor openings in 2019.
- With encouragement from the EIC, an Officer Wellness Module was offered for the first time in the PELC 72 class. Officer Wellness continued through PELC 73-74 with increased hours of instruction.
