4:00 pm Bellows Ballroom	General Session II – “Emotional Survival for Law Enforcement Officers and their Families“ Dr. Kevin Gilmartin <i>Facilitator: Chief Roy Mosley, CLEE</i> <p>This presentation will assist leaders to understand the short and long-term emotional effects of law enforcement work on their officers, which can adversely affect their personal and professional lives. The concept of <i>hypervigilance</i> will be explored, and how it can alter the initial enthusiasm and the desire to perform professionally in the law enforcement officer into increased negative cynicism, social distrust, and emotional isolation. The adverse result is the erosion of work performance, poor decision-making, and ultimately the deterioration of the officer’s overall quality of life.</p> <p>Dr. Gilmartin will offer effective strategies to achieve emotional survival, not just for the officer, but for their families as well, who are also deeply impacted. Through increased awareness and commitment to employ effective strategies, the law enforcement leader can achieve a department of officers and other employees who are committed and engaged in productive police work and service to their communities.</p>

Many law enforcement executives believe that the hiring paradigm is impossible to change but progressive agencies are finding new ways to identify and develop recruits over an extended period instead of using the "test and hire" approach.</p> <p>In this session, a panel of experts who have knowledge and experience in the process of recruiting, hiring, developing, and retaining peace officers will share their ideas, concepts, strategies, best practices, and successes that will guide workshop participants in identifying peace officer candidates who align with the policing philosophy of their communities. Additionally, the panel will discuss how to create an agency succession plan by developing the next generation of law enforcement leadership.</p>

The OACP Patrolling Chiefs Committee has worked to initiate more specific conversations relating to Police Chiefs who divide their responsibilities between the administration and general patrol. The makeup of the committee includes police chiefs from villages, townships, and college campuses in all six districts across the State of Ohio. Patrolling Chiefs have shared best practices, grant resources, and personnel issues, and discussed a variety of new and old challenges we all face throughout our respective tenures.

Participants have taken steps to build a network amongst similar size departments and explore common challenges such as hiring and recruitment, governing body relationships, budget development, and much more. In 2022, the committee worked to provide model policies for operations and field training but more importantly, worked with OCJS and Dr. Patrick Oliver to develop the first hiring and recruitment grant specifically indicated for small agencies. The committee provided direct and indirect training for members wishing to learn more about the grant and the grant writing process. We are excited to offer this roundtable discussion and look forward to learning more about how the OACP and its committees can better serve Patrolling Chiefs once again.
