- Commitment: Deep dedication to professional development, fostering a positive organizational culture, mentoring colleagues, and contributing to the advancement of the policing profession.
- Community Impact: Significant contributions to public safety initiatives, proactive community engagement efforts, or the development of partnerships that strengthen trust and enhance delivery service to the public.
- Additional consideration for advanced training that was successfully completed: STEP, PELC, CLEE, FBINA, etc.
